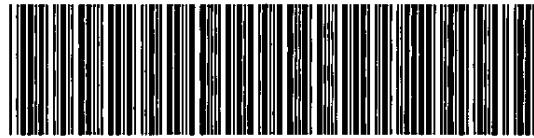

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following articles of amendments to its Articles of Organization:

**First:** This amendment is submitted to amend the following:

**ARTICLE III. PURPOSE**

The purpose for which the corporation is organized is to own common areas in the Back Nine Subdivision, Taylor County, Florida and administer and enforce covenants and restrictions on individual homeowners as a part of a homeowners association.

The Association shall operate, maintain, and manage a Surface Water or Storm Water Management System(s) in a manner consistent with Suwannee River Water Management District (" District") permit No. ERP06-0107M and applicable District rules, and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the Surface Water or Storm Water Management System(s).

The Association shall levy and collect adequate assessments against the member of the Association for the costs of maintenance and operation of the Surface Water or Storm Water Management System(s).

**ARTICLE XII. MISCELLANEOUS**

Should a conflict exist or arise between any of the provisions of the Articles of Incorporation and the provisions of the Bylaws, the provisions or the Articles of Incorporation shall control.


