**ARTICLES OF INCORPORATION**  
**OF**  
**OAK GROVE MISSIONARY BAPTIST CHURCH OF GENEVA, INC.**  
**A NON-PROFIT CORPORATION**

The undersigned subscribers, desiring to form a corporation not for profit under Chapter 617, Florida Statutes, as amended, hereby adopt the following Articles of Incorporation:

**ARTICLE I**  
**NAME**

The name of the corporation shall be **OAK GROVE MISSIONARY BAPTIST CHURCH OF GENEVA, INC.**, a non-profit corporation, which is hereinafter referred to as "the Corporation".

**ARTICLE II**  
**PURPOSE AND CORPORATE EXISTENCE**

The specific purpose for which this Corporation is organized is exclusively religious, educational, or charitable, within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1986, as amended.

The Corporation shall have perpetual existence.
