**ARTICLES OF INCORPORATION**

**OF**

**L. A. AINGER MIDDLE SCHOOL PTO, INC.**

The undersigned subscribers hereby associate themselves together for the purpose of forming a corporation not for profit under and by virtue of the laws of the State of Florida, and under the following charter:

ARTICLE I NAME

The name of this corporation shall be:

L. A. AINGER MIDDLE SCHOOL PTO, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

ARTICLE IX

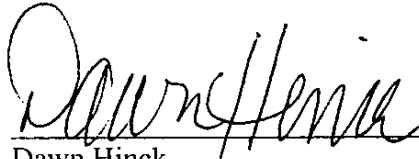
The membership of this corporation shall have the power to make, alter or rescind the Articles of Incorporation of this corporation in accordance with the provisions set forth in the By-Laws.

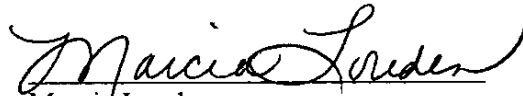
ARTICLE X
