ARTICLES OF INCORPORATION

OF

L. A. AINGER MIDDLE SCHOOL PTO, INC.

The undersigned subscribers hereby associate themselves together for the purpose of forming a corporation not for profit under and by virtue of the laws of the State of Florida, and under the following charter:

ARTICLE I NAME

The name of this corporation shall be:

L. A. AINGER MIDDLE SCHOOL PTO, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized and will be operated exclusively for is charitable and educational purposes within the meaning of 501(C)(3) of the Internal Revenue Code. Specifically, the corporation is organized to support the education of children at L.A. Ainger Middle School by fostering relationships between the school, parents and teachers. In pursuance of these purposes it shall have the powers to carry on any business or other activity which may be lawfully conducted by a corporation organized under Florida law, whether or not related to the foregoing purposes, and to do all things necessary, proper and consistent with maintaining tax exempt status under 501(C)(3).
