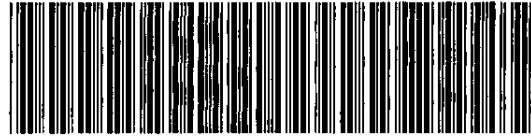

ARTICLES OF INCORPORATION
In compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME
The name of the corporation shall be: h2HOPE, INC.

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE
The purpose for which the corporation is organized is:
Said corporation is organized exclusively for charitable, religious and educational reasons, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. The Corporation's purpose is to promote charity, hope and faith through bottled water with a focus on the homeless, hungry and hopeless and their families. This will begin with the production and distribution of private labeled bottled water to provide financial assistance to these groups. The Corporation shall network with Christian churches, charity organizations, halfway houses, and social agencies to facilitate this charitable, religious and educational outreach. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future Federal tax code. Any assets not so disposed shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is located. Disposal shall be made exclusively for exempt or public purposes, or be made to such organization or organizations as the court shall determine to be organized exclusively for such purposes.

ARTICLE IV MANNER OF ELECTION The manner in which the directors are elected and appointed:
The Board of Directors shall appoint successors to all Board positions which have come to term at the regularly scheduled fourth quarter meeting by majority vote. There are no term limits. Positions vacated before fulfilling the term will be filled by appointment of the President.
