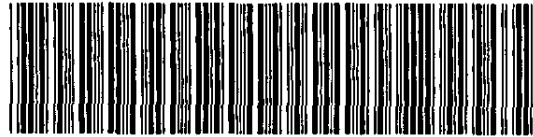

AMENDING ARTICLE III-PURPOSE (LAST PARAGRAPH page 2 OF 6)

LABORING In The Word Bible College, Inc. exists to fill the vital role of training students to fulfill roles of pastor, teacher, counselor or businessman.
