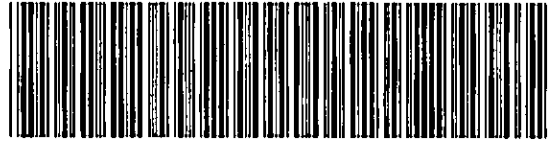

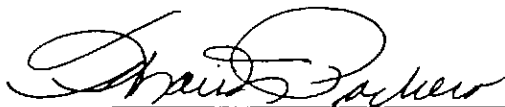
ARTICLE 1

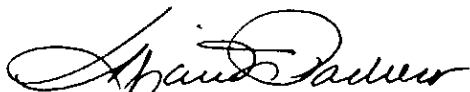
