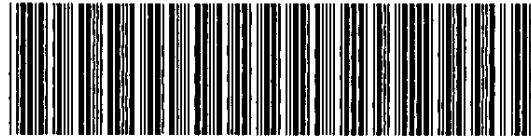



ARTICLES OF INCORPORATION

OF

NATIONAL PRINT OWNERS ASSOCIATION OF NORTH AMERICA, INC.

The undersigned, acting as incorporator of this corporation pursuant to Chapter 617 of the Florida Statutes, hereby forms a corporation not for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be NATIONAL PRINT OWNERS ASSOCIATION OF NORTH AMERICA, INC.

ARTICLE II - TERM OF EXISTENCE

This corporation shall have perpetual existence, commencing with the filing of these Articles of Incorporation with the Secretary of State.

ARTICLE III - ADDRESS OF PRINCIPAL OFFICE

AND MAILING ADDRESS OF CORPORATION

The address of the principal office of the corporation is 2110 South Dairy Road, West Melbourne, Florida 32904, and the mailing address of the corporation is 2110 South Dairy Road, West Melbourne, Florida 32904.

ARTICLE IV - PURPOSES AND POWERS OF CORPORATION

A. The corporation is organized as a not for profit organization to educate its members regarding the printing industry through educational programs, publications, seminars, research, and dissemination of technical information and data.

B. This corporation shall be authorized to carry out any and all acts and to exercise any and all corporate powers which may now or hereafter be lawful under the laws of the

State of Florida to the extent applicable to corporations not for profit and that are not inconsistent with these Articles of Incorporation.

ARTICLE V - ELECTION OF DIRECTORS

The Board of Directors of the corporation shall be elected as provided in the Bylaws. The Board of Directors shall at all times consist of at least seven (7) persons.

ARTICLE VI - INITIAL REGISTERED OFFICE

AND REGISTERED AGENT

The street address of the initial registered office of the corporation is 360 North Babcock Street, Suite 104, Melbourne, Florida, 32935, and the name of the initial registered agent of this corporation at that address is JOEL E. BOYD. The Board of Directors may from time to time designate a new registered office and registered agent.




