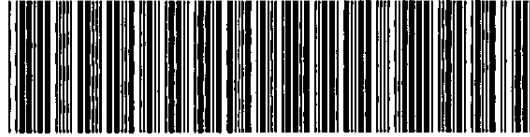



AMENDMENT TO ARTICLES

ATTACHMENT TO ITEM E:

The articles are hereby amended as follows:

Article III is amended to read as follows:

The specific purpose for which this corporation is organized is: The corporation is organized exclusively for charitable, religious, educational, or scientific purposes under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. The specific purpose of the Corporation is to rescue dogs from Florida shelters, train them and give them as companion dogs to United States veterans and/or family members who can benefit from such a dog. K-9s for Heroes also offers a work program to unemployed veterans and non-veterans who are striving to regain dignity and financial independence. Donations collected support the programs offered by this Corporation.

Additional Articles shall be added as follows:

Article IX – Powers

The Corporation will have all powers granted by law to not-for-profit corporations subject to the limitations described elsewhere in these Articles of Incorporation and as may be required in order for the Corporation to maintain its nonprofit and tax-exempt status under both Florida law and the Internal Revenue Code, as amended from time to time, or its successor laws and regulations (the “Code”). Notwithstanding any other provision of these Articles of Incorporation, the Corporation will not carry on any other activities not permitted to be carried on: (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Code; or (b) by a corporation contributions to which are deductible under Section 170(c)(2) of the Code. In attempting to fulfill the general nature of the objectives of this Corporation, and to ensure that it meets with the requirements of an exempt organization under Section 501 (c)(3) of the Code, the Corporation will strictly adhere to the following:

- (1) The Corporation will not engage in any act of self-dealing as defined in the Code that would jeopardize its tax-exempt status;
- (2) The Corporation will not allow its members or directors to have a vested interest in its assets
- (3) The Corporation will not make any investments which would jeopardize its charitable purpose.

Article X - Limitation on Activities

No part of the net earnings of the Corporation will be for the benefit of, or be distributable to, any member, director or officer of the Corporation or any other private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes). Nothing in these Articles of Incorporation restricts the Corporation from reimbursing the members for funds borrowed by the Corporation or paying reasonable compensation for services performed.

Article XI – Dissolution

Upon dissolution of this Corporation, after providing for all of the Corporation's liabilities, all assets of the Corporation shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. None of the net assets of the Corporation will be distributed to or for the benefit of any member, trustee, officer or director of the corporation or to any other individual.
