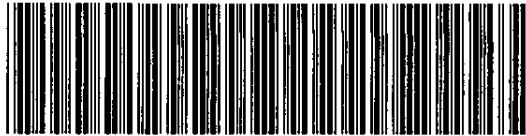



In compliance with Chapter 617, F.S. (Not for Profit), the undersigned, a natural person, for the purpose of organizing a corporation not-for-profit and without stock, under the requirements of the laws of the State of Florida, does hereby act as incorporator for the Organization for Associate Degree Nursing Foundation, Inc. and files these Article of Incorporation which state:

**ARTICLE I
NAME**

The name of the corporation (hereinafter referred to as the "Corporation") is:

Organization for Associate Degree Nursing Foundation, Inc.

**ARTICLE II
PRINCIPAL OFFICE**

**ARTICLE III
PURPOSE**

The purpose for which the corporation is organized:

First, to promote, encourage and foster the curriculum, studies, scholarship, and other educational endeavors and opportunities in the field of nursing; and,

Secondly, to conduct any lawful business and engage in any lawful act or activity consistent with Federal Law and Florida State Law under Chapter 617, F.S. and the United States Internal Revenue Code of 1986 as the same may be amended or supplemented (the "Code"), and such other laws governing not-for-profit non-stock corporations exempt from Federal income tax under Section 501(e)(3) of the Code.

The Corporation is not organized for pecuniary profit or for the benefit of any individual or for-profit entity and shall not have authority to issue capital stock. The Corporation is organized exclusively for charitable, educational or scientific purposes, including, for such purposes, the making of distributions to organizations exempt from Federal income tax under Section 501(c)(3) of the Code. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its directors, officers, or committee members, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth herein.

Notwithstanding any other provision of these Articles of Incorporation, the Corporation shall not carry on any activity not permitted to be carried on: (i) by a corporation exempt from Federal income tax under section 501(c)(3) of the Code; or (ii) by a corporation contributions to *which* are deductible under section 170(c)(2) of the Code. No substantial part of the activities of the Corporation shall be the carrying on as propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements), any political, campaign on behalf of, or in opposition to, any candidate for public office.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The Corporation shall have no members. The directors of the Corporation shall be elected at the Annual Meeting of the Board of Directors of the Organization for Associate Degree Nursing Foundation, Inc., a Florida non-profit corporation, by the affirmative vote of a majority of the directors of the Organization for Associate Degree Nursing Foundation, Inc. present at such meeting, provided a quorum (defined as a majority of the directors of the Organization for Associate Degree Nursing Foundation, Inc. in office) is present.




