

In Compliance with Chapter 617 Florida Statutes, (Not for Profit) SECRETARY OF STATE TALLAHASSEE FLORIDA

### **ARTICLE 1** NAME

The name of the Non For Profit Corporation or Organization shall be:

### **ARTICLE V DURATION**

The period of the Corporation/Organization's duration is perpetual

### **ARTICLE VI PURPOSE**

The purpose for which the Non-For Profit Corporation/Organization is organized is:

- A. Said organization is organized exclusively for help Victims of Domestic Violence, Human Trafficking, educational and charitable purpose, without any discrimination of race of color, religion and even if the victim's primary language is not English, as in the case have a native language of other countries, including for such purposes the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or Corresponding action of any future federal tax code.
- B. No part of the net earnings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and make payments and distributions in furtherance of the purposes set forth in the purpose clause. The organization shall not carry on any provisions of this document, the organization should not carry on any organization exempt from federal income tax under section

501 (c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code, or (b) by an organization, contributions to which are deductible under section 170(c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code and corresponding section of the State of Florida Non-Profit Corporations/Organizations.

C. Upon dissolution of the Corporation/Non-Profit Organization or the winding up of its affairs, the assets of the Corporation/Organization shall be distributed exclusively to other Non-Profit or Charitable organizations which would then qualify under the provisions of Section 501(c) (3) of the Internal Revenue Code and its regulations as they now exist or as they hereafter be amended.

D. the Corporation/Organization is organized pursuant of the Florida Non-Profit Corporation Act and does not contemplate pecuniary gain or profit and is organized for nonprofit purposes.
