Oak Hill Farms Unit I Neighborhood Association Annual Meeting Minutes

The annual meeting of the Oak Hill Farms Unit I was held on January 31, 2007, at the home of Frank Beck.

In attendance: Frank Beck, Dennis Horton, Connie Sundquist, Peter Dalton, Jan McLaughlin, Scott & Christy Ashley

I. The meeting was called to order at 7:15 pm by Frank Beck, Association President.

II. Treasurer's Report

Connie Sundquist, Secretary/Treasurer, presented the financial report (copy attached). The ending balance as of 1/31/07 was \$110.45. Frank Beck and Dennis Horton directed the secretary/treasurer to send a certified letter to all homeowners owing outstanding assessments with a warning that a lien may be placed on their property if not paid by April 15, 2007. Ms. Sundquist will need approximately \$50.00 for the 2007 assessment mailout supplies.

III. Old Business

Five truck loads of milling and labor at a cost of \$2350.00 was purchased with available funds on 10/4/06.

Members discussed the speed limit signs, but since Beverly Graddy was absent, there was no update on the costs.

IV. New Business

Election of Officers

Frank Beck, Dennis Horton and Connie Sundquist agreed to remain in their current board positions. All voted in favor.

It was suggested that the association update the contact information for all members to include work phone numbers in case of emergencies in the neighborhood. An update form will be mailed out with the 2007 assessment mailout and anyone requesting a copy can contact the secretary/treasurer.

V. Open Discussion

Frank Beck requested an explanation of why we need to maintain the liability insurance. Frank Dalton spoke on this and all agreed it was necessary to protect the homeowners from lawsuits if someone was injured on the common property.

Discussion was held on the maintenance of the entry on Buck Lake & Green Hill Trace. Members have been taking care of it but there is a need to contract services to maintain it on a regular basis so there is no hardship on any one member and the entrance remains attractive and clean for all to enjoy. Frank Beck will follow up on the costs to provide this service.
