**ARTICLES OF INCORPORATION OF  
NAUTILUS POINTE AT INLET BEACH OWNERS' ASSOCIATION, INC.,  
a Florida non-profit corporation**

The undersigned incorporator executes these Articles of Incorporation for the purpose of forming a corporation not for profit under the laws of the State of Florida, and adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

The name of this corporation is **NAUTILUS POINTE AT INLET BEACH OWNERS' ASSOCIATION, INC.** For convenience, the corporation shall be referred to in this instrument as the "Association," these Articles of Incorporation as the "Articles," and the bylaws of the Association as the "Bylaws."

**ARTICLE II**

**TERM OF EXISTENCE**

The Association shall have perpetual existence.

**ARTICLE III**

**CORPORATE PURPOSE**

This Association is organized for the purpose of providing a non-profit entity under Florida Statute 720.301-720.318 (2020) (the 'Statute') for the operation of the Association governing the residential subdivision in Walton County, Florida known as Nautilus Pointe at Inlet Beach.
