Pursuant to the provisions of Section 617.1006 of the Florida Not For Profit Corporation Act, DREAMS UNITED CHURCH, INC., a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

*ARTICLE I*

Name

The name of the corporation is DREAMS UNITED CHURCH, INC. The Articles of Incorporation of the Corporation were filed with the Florida Secretary of State on January 19, 2023, Document Number N23000000463.

*ARTICLE II*

Amendment
