ARTICLE ONE

NAME

The name of the corporation is AMVETS POST 92, INC.

ARTICLE TWO

DURATION

The term of existence of the corporation is perpetual.

ARTICLE THREE

PURPOSE

The corporation is organized in order to engage in any lawful purposes not for pecuniary profit. The major function of the organization is to associate veterans of American Wars.

ARTICLE FOUR

The street address of the initial principal office of this corporation is 2087 N.E. Dixie Highway, Jensen Beach, FL 34957, and the name of the initial registered agent of this corporation at that address is Peter Robert Phoenix.

ARTICLE FIVE

DIRECTORS


