ARTICLES OF INCORPORATION
OF
K-9 SEARCH & RESCUE OF SOUTH FLORIDA, INC.

THE UNDERSIGNED INCORPORATOR of these ARTICLES OF INCORPORATION, natural person competent to contract, hereby adopts the following ARTICLES OF INCORPORATION for the purpose of forming a non-profit corporation under the laws of the State of Florida.

ARTICLE I

NAME

The name of the corporation is K-9 SEARCH & RESCUE OF SOUTH FLORIDA, INC.

ARTICLE II

PURPOSE

This non-profit corporation is organized for the purpose of serving the people of the State of Florida and of the United States of America by offering charitable services as a search and rescue unit and any and all other services which the non-profit organization can accomplish. This corporation is to be a not for profit corporation.

ARTICLE III

MEMBERSHIP

There shall not be any capital stock authorized to be issued. This is a not for profit corporation and shall consist solely of various types of memberships. In furtherance and not in limitation of the powers conferred by Florida Statute, the Board of Directors is expressly authorized to create, alter or repeal the various types of memberships according to the procedures of this corporation's By-Laws.

ARTICLE IV

DURATION

This corporation is to exist perpetually commencing at the date of filing of the Articles of Incorporation by the Department of State, The State of Florida.

ARTICLE V

DIRECTORS

The corporation shall have four (4) directors initially. The number of directors may be increased from time to time pursuant to the By-Laws of the corporation adopted by the membership, but there shall never be less than three (3) directors. Each and every January of each year, the general membership shall hold elections for the officers and directors of the Board of Directors of this corporation. Elections shall be held according to the By-Laws of the corporation. Amendment of our Articles of Incorporation:

ARTICLE IX
AMENDMENT

A. The purposes for which the corporation is organized are exclusively charitable and educational within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax section 501 (c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

C. Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for a public purpose. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction, in the county in which the principal office of the organization is then located, exclusively for such purposes.
