ARTICLES OF INCORPORATION

THESE ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF THE OAKBRIDGE HOMEOWNERS ASSOCIATION, INC., a Florida non-profit corporation ("Articles of Amendment"), are made effective January 4, 2021, by **THE OAKBRIDGE HOMEOWNERS ASSOCIATION, INC.,** a Florida non-profit corporation (the "Association").

RECITALS:

A. The Association desires to amend its Articles of Incorporation as more particularly described hereafter and these Articles of Amendment were approved by a majority vote of the Board of Directors at a duly held meeting of the Association's Board of Directors held on January 4, 2021, in the manner prescribed by Article IX of the Articles of Incorporation.

NOW THEREFORE, the Association hereby amends its Articles of Incorporation as follows:

1. To the extent not otherwise specifically defined herein, all capitalized terms contained in this Amendment shall have the same meanings as such terms are defined in the Association's Articles of Incorporation as amended prior to the date hereof.

2. Article VI is hereby amended in its entirety as follows:

(a) The affairs of the Association shall be managed by a Board of Directors consisting of seven (7) Directors. The Directors shall be members of the Association and shall be elected in the manner provided in the Bylaws.

3. Except as specifically amended hereby, the Association's Articles of Incorporation as amended prior to the date hereof, shall remain in full force and effect.

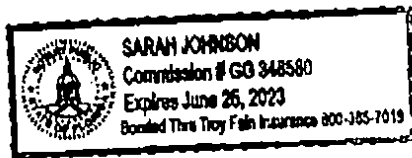
