ARTICLES OF AMENDMENT OF OAK COURT ASSOCIATION, INC.

Pursuant to the provisions of Section 617.1001 of the Florida Corporation Not for Profit Act, the above corporation hereby adopts the following articles of amendment to its articles of incorporation.

- 1. The name of the corporation is OAK COURT ASSOCIATION, INC.
- 2. The amendment to the Articles of Incorporation of the Corporation provides that Article X. Term be amended as follows:

This Corporation shall have perpetual existence, however, should for any reason it be dissolved, the surface water management system and all property associated therewith shall be dedicated and conveyed to an appropriate agency of local government and that if not accepted, then same shall be conveyed to a similar non-profit corporation, or other qualifying responsible party.

3. The above amendment was duly adopted by written consent of all directors of the corporation on March 20, 1997. There are no members entitled to Vote.


