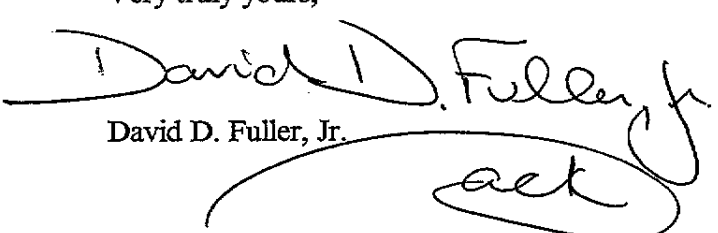

**THE UNDERSIGNED** subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation not for profit under the laws of the State of Florida.

**ARTICLE I-NAME**

The name of the corporation shall be EAA International Aerobatic Club Chapter 111, Inc.

**ARTICLE II-TERM OF EXISTENCE**

The corporation shall have perpetual existence.

**ARTICLE III-PURPOSES**

The purposes of the corporation shall be as follows:

- A. To promote and encourage the sport and hobby of recreational aviation.
- B. To cooperate with and assist government agencies in the development of programs that promote and support recreational aviation.
- C. To promote and encourage aviation, education and safety in the design, construction, restoration and flying of all types of aviation vehicles.
- D. To provide aviation enthusiasts at all levels the opportunity to participate in grassroots aviation activities.
- E. To foster closer fellowship among its members through the exchange of ideas of mutual interest.
- F. To actively support and promote the mission and vision of the Experimental Aircraft Association and its Divisions through the outreach activities of a local Chapter
- G. To encourage, aid and engage in research, including that of a scientific nature, for the improvement and better understanding of aviation and the art of aerobatics.
- H. To promote and encourage aerobatic education and competition, on a national and international level.

ARTICLE IV-ADDRESS

The street address of the initial principal office of the corporation shall be 30 Lazy Eight Drive, Daytona Beach, Florida 32124. The Board of Directors may from time to time move the principal office to any other address.

ARTICLE V-DIRECTORS

The corporation shall have three (3) directors initially. The number of Directors shall be as set forth in the Bylaws but in no event shall the number of Directors be less than three. The Directors shall be elected by the membership as provided in the Bylaws.
