## ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SABAL CHASE PROPERTY OWNERS, INC.

99 MAY 24 PM 5: 47
SECTION STALLAHASSLE, ILONDA

Pursuant to Chapter 617, *Florida Statutes* (1997), of the Florida Not For Profit Corporation Act, the undersigned Corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

- The name of the Corporation is SABAL CHASE PROPERTY OWNERS,
   INC. (hereinafter "Corporation").
- 2. The following amendment of the Articles of Incorporation was adopted by Joint Unanimous Written Consent of the Board of Directors, dated May 21, 1999, in accordance with the provisions of Article IX of the Articles of Incorporation of the Corporation and Section 617.1002, *Florida Statutes*; no members were or are entitled to vote:
  - a. A new Article X is added and shall read as follows:

## ARTICLE X

The Corporation shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. Johns River Water Management District ("District") Permit No. 4-009-0612A-ERP requirements and applicable District rules and shall assist in the enforcement of the Declaration of Covenants and Restrictions which relate to the surface water or stormwater management system.

The Corporation shall levy and collect adequate assessments against members of the Corporation for the costs of maintenance and operation of the surface water or stormwater management system.

In the event of termination, dissolution or final liquidation of the Corporation, the responsibility for the operation and maintenance of the surface water or stormwater management system must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approved by the District prior to such termination, dissolution or liquidation.

A new Article XI is added and shall read as follows: b.

## ARTICLE XI

The Corporation shall have perpetual existence.

The effective date of this amendment to the Articles of Incorporation of the 3. Corporation will be as of the date of filing of these Articles of Amendment to the Articles of Incorporation with the Secretary of State for the State of Florida.
