The undersigned, acting as incorporator of a Corporation pursuant to Chapter 617, Florida Statutes, adopts the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be **KENANSVILLE COMMUNITY ASSOCIATION, INC.** proposed place of business shall be P. O. Box 41, 1180 South Canoe Creek Road, Kenansville, Florida 34739.

ARTICLE II

The period of the duration of this corporation shall be perpetual, unless dissolved according to law.
