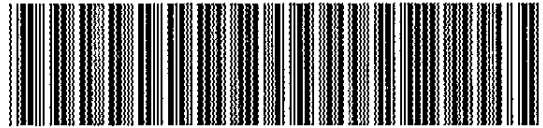

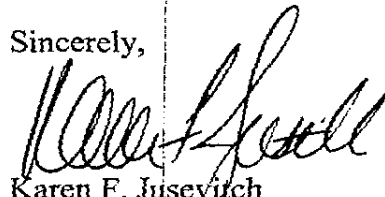

THE UNDERSIGNED, Franz Ritucci, Jr., M.D., President of AMERICAN ACADEMY OF AMBULATORY CARE, INC., a Florida not-for-profit corporation (the "Corporation"), for and on behalf of the Corporation, hereby executes these Articles of Amendment to the Articles of Incorporation of the Corporation:

ARTICLE FIRST: The name of the Corporation is:

AMERICAN ACADEMY OF AMBULATORY CARE, INC.

ARTICLE SECOND: The first amendment to the Articles of Incorporation of the Corporation effected by these Articles of Amendment is that ARTICLE I of the current Amended and Restated Articles of Incorporation is amended to provide as follows:

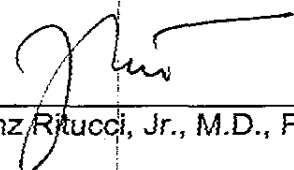
ARTICLE I – NAME OF CORPORATION

The name of this corporation shall be: AMERICAN ACADEMY OF URGENT CARE MEDICINE, INC.
