**ARTICLES OF INCORPORATION  
OF**

**L. A. APLEY PROFESSIONAL MANAGEMENT FOUNDATION, INC.**

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not-for-Profit Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of this corporation is L. A. Appley Professional Management Foundation, Inc.

**ARTICLE II - PURPOSE**

The purpose of this corporation is to conduct any lawful business activity permitted by the laws of the State of Florida for not-for-profit corporations. The corporation shall not engage in any action which is not permitted to be carried on (a) by a not-for-profit corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The organization is a not-for-profit corporation established in order to achieve vital public-interest objectives that can result from promoting and creating widespread usage of professional management practices developed and advocated by such professional management leaders as L. A. Appley, former Chairman of the American Management Associations. The corporation is devoted to the widespread public education of professional management practices as a means of achieving the continuous improvement of America and its international partners.

The purposes include, but are not limited to, the extensive research, development and application of professional management systems in order to advance the Quality-of-Life in America by advancing the world-wide competitive capabilities of present and future managers. Purposes vital to the organization also include the following:

(a) to structure the basic management processes...developed by L. A. Appley and other leaders during the 20th century...into a simple yet powerful and practical system of professional management methods, tools and techniques.

(b) to create a teaching/learning system capable of training managers and team members to achieve a very high level of management skill competency in all sizes and types of organizational units...in both the private and public sectors of our society.

(c) to use advanced communication and information technologies that can provide both interactive, self-study methods and life-long learning opportunities to help ensure the widespread utilization of the Professional Management System...not only in the 21st century but throughout the new millenium.

**ARTICLE III - NONSTOCK BASIS**

The corporation is organized on a nonstock basis within the meaning of the Florida Not-for-Profit Corporation Act, but may issue membership certificates if so provided in the corporate by-laws.

**ARTICLE IV - EXISTENCE**

The corporation shall have perpetual existence.

**ARTICLE V - PRINCIPAL OFFICE**

The principal office of this corporation shall be located in the City of Clearwater, County of Pinellas, State of Florida and the address of said principal office shall be 28870 U.S. Hwy. 19N, Suite 300, Clearwater, Florida 33761.

**ARTICLE VI - DIRECTORS AND THEIR ELECTION**

The number of directors of this corporation shall be not less than three nor more than seven. The method of election of directors shall be as stated in the by-laws of the corporation.

**ARTICLE VII - INCORPORATOR**


