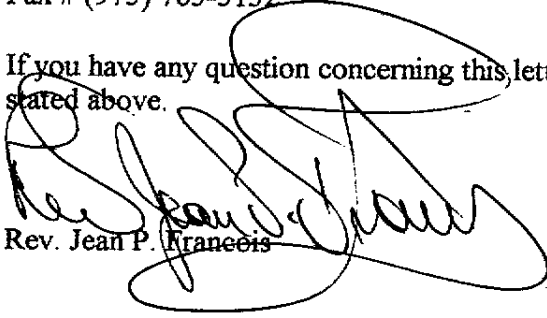

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for profit Corporation Act, hereby adopt(s) the following Articles of Incorporation:

**ARTICLE I NAME**

**ARTICLE III PURPOSE (S)**

The specific purpose(s) which the corporation is organized is (are):

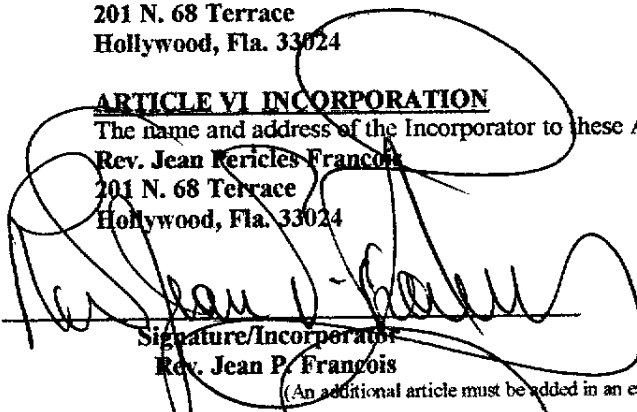

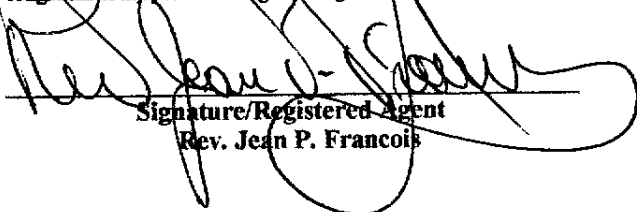
