

The undersigned incorporator, for the purpose of forming a corporation under Chapter 607 and/or 621, Fla. Stat., hereby adopts the following Articles of Incorporation:

ARTICLE I

NAME OF THE CORPORATION

The name of the corporation (the "Corporation") shall be: Braman Motorsports, Inc.

ARTICLE II

PRINCIPAL OFFICE

The principal place of business and the mailing address of this Corporation shall be 2060 Biscayne Boulevard, Second Floor, Miami, FL 33137.

ARTICLE III

PURPOSES

The purposes for which this corporation is to be formed are as follows:

To carry on any business and to have and exercise all the powers conferred by the State of Florida upon corporations formed under the laws of the State of Florida.




