**ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
BRAMAN MOTORSPORTS, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of this Corporation is BRAMAN MOTORSPORTS, INC. (hereinafter called the "Corporation").
2. Article I of the Corporation's Articles of Incorporation is deleted and replaced by new Article I, as follows:

**"ARTICLE I**

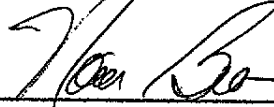
**NAME OF THE CORPORATION**

3. Except as hereby amended, the Articles of Incorporation of the Corporation shall remain the same.
4.
