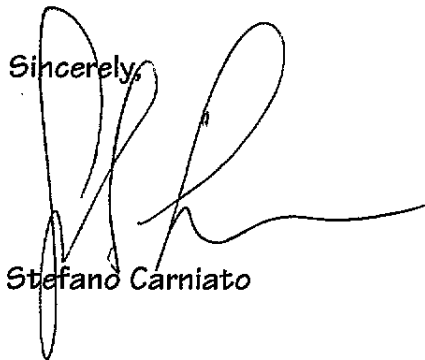

**ARTICLES OF INCORPORATION**

The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the corporation shall be: P9 Inc.

**ARTICLE II - ADDRESS**

The principal place of business and mailing address shall be: 2699 Collins Avenue, Suite 141, Miami Beach, Florida 33140.

**ARTICLE III - PURPOSE**

The corporation may engage in or transact any lawful activity or business permitted under the laws of the United States and the State of Florida.

**ARTICLE IV - AUTHORIZED SHARES**

The maximum number of shares that the corporation is authorized to have outstanding at any time is 100 shares of common stock with a par value of \$1.00 per share.

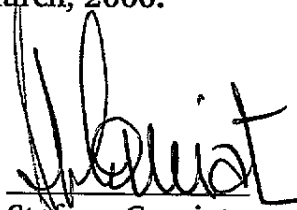
**ARTICLE VII - BYLAWS**

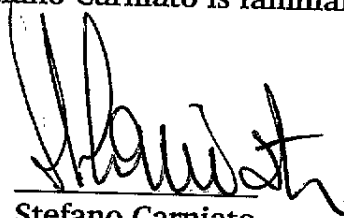
