ARTICLES OF INCORPORATION

ARTICLE I

The name of the Corporation is O2NH, Inc. The address of the Corporation is 1437 72nd Avenue NE, St. Petersburg, Florida 33702.

ARTICLE II DURATION

The Corporation shall have perpetual existence.
