The undersigned incorporators, George Larry Baber, Jr. and Karen Robin Baber, hereby forms GARAK INVESTMENTS, INC., a corporation for profit under the Florida General Corporation Act and other laws of the State of Florida.

1. NAME OF CORPORATION AND INITIAL ADDRESS: The name of this corporation shall be GARAK INVESTMENTS, INC. and its address is 4142 Dorchester Court, Chipley, Florida 32428.

2. TERM OF EXISTENCE: This corporation shall exist perpetually unless dissolved according to law.
