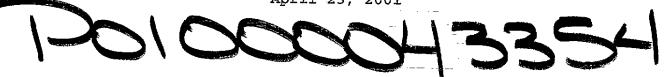

ARTICLE I. CORPORATE NAME. SECRETARY OF STATE
