Pursuant to the provisions of section 606.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

**FIRST:** Amendments adopted:

Article FIRST of the Articles filed on June 15, 2001 wherein the name of the corporation is MLAMFS, Inc. is being amended to the new corporate name of KadeMA, Inc.
