## ARTICLES OF INCORPORATION

OF

#### KABINET MASTERS, INC.

#### ARTICLE 1 - NAME

The name of the corporation shall be:

Kabinet Masters, Inc.

### **ARTICLE 2 – DURATION**

This corporation shall exist in perpetuity.

#### ARTICLE 3 – PURPOSE

General nature of business and the object and purpose proposed to be transacted and carried on, are to do any and all of the things mentioned herein, as fully and to the same extent as natural personas might or could viz: Engage in any business or activity permitted under the laws of the United States and State of Florida, including but not limited to the following:

- a) To take, acquire, buy, hold, own, maintain, work develop, sell, convey, lease, mortgage, exchange, improve and otherwise invest in and dispose of the real estate and real property or any interest or rights therein without limit as to the amount to do all things and engage in all activities necessary and proper or incidental to the business of investing in and developing real estate.
