ARTICLE I

The name of the corporation shall be TABOR LAKE DEALERSHIP, INC.



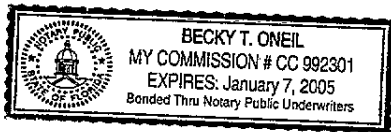
