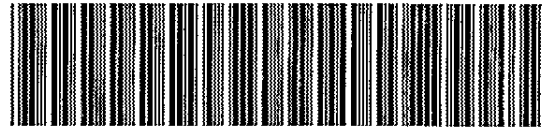


ARTICLE X - INDEMNIFICATION

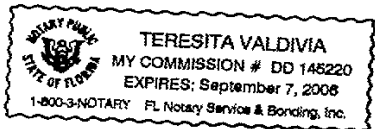




