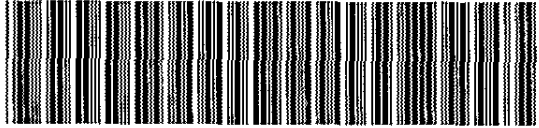

ARTICLES OF INCORPORATION

The undersigned, acting as an incorporator for the purpose of forming a corporation under and by virtue of the Laws of the State of Florida, adopt the following Articles of Incorporation.

ARTICLE I

EFFECTIVE DATE

02-10-03

The name of the corporation shall be E3 Consulting Services, Inc. and its initial place of business shall be at 2961 Byington Circle, in the City of Tallahassee in the County of Leon and the State of Florida.

ARTICLE II

The purpose of the corporation is to engage in the transaction of any and all business permitted under the Laws of the United States and of the State of Florida.

ARTICLE III

The total number of shares authorized to be issued by the corporation shall be one hundred shares of common stock. The board of directors shall have the authority to issue additional series and /or classes of stock pursuant to Florida Law, and by the by laws of the Corporation. Shares of capital stock in this corporation shall be issued initially to the following persons in the amount indicated:

Shares held by the initial share holders listed above may not be resold or otherwise transferred to other persons unless such shares are first offered to the remaining share holders or to the Corporation. The price and terms and the time within which shares may be offered and sold shall be further specified by written agreement among the shareholders and this Corporation.

ARTICLE IV

Every shareholder, upon the sale for cash of any new stock of the Corporation of the same kind, class, or series, as that which he now holds, still have the right to purchase his prorata share thereof, as nearly as may be done without the issuance of fractional shares, at the price at which said stock is offered to others.

ARTICLE V

The term for which said corporation shall exist shall be perpetual.


