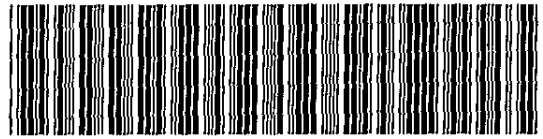

**ARTICLES OF INCORPORATION
OF

The undersigned, desiring to form a corporation under the Florida General Corporation Act, makes and subscribed to the following Articles of incorporation.

ARTICLE I

The name of this corporation is **MAA KRUPA, INC.**

**ARTICLE II
DURATION**

This corporation shall have perpetual existence.

**ARTICLE III
CORPORATE PURPOSE**

The general nature or purpose for which this corporation is initially organized is to engage in any activity or business permitted under the laws of the United States of America and under the Florida General Corporation Act; provided, however, that this corporation shall not conduct a banking, safe deposit, trust, insurance, surety, express, railroad, canal, telegraph, telephone of cemetery company, building and loan association, fraternal benefit society, state fair or exposition.

**ARTICLE IV
CAPITAL STOCK**

The corporation is authorized to issue 2,000 shares of \$1.00 par value capital stock. The shares of the corporation are not to be divided into classes. The capital stock of the corporation shall qualify as Small Business Company Stock pursuant to Section 1244 of the Internal Revenue Code.

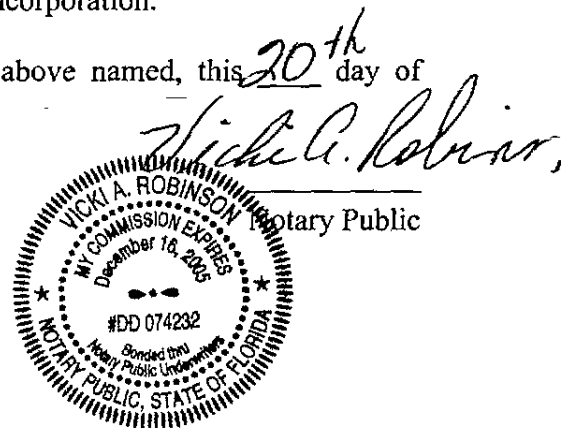
