

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF PURPLE TREE TECHNOLOGIES, INC.

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation's Act, the undersigned Corporation adopts the following Articles of Amendment to the Articles of Incorporation.

- 1. Article IV is hereby amended to read as follows: The maximum number of shares this Corporation is authorized to issue is 20,000, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
- 2. The Amendment to the Articles of Incorporation was adopted on October 1, 2003.
- 3. The Amendment was approved by unanimous consent of all the Shareholders. The number of votes cast for approval was sufficient.

In all other respects, the Articles of Incorporation shall remain as they were prior to this Amendment being adopted.
