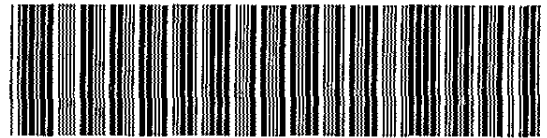

**ARTICLE I - NAME**

The name of the corporation formed pursuant to these Articles of Incorporation is K-10 Design and Development, Inc.
