

ARTICLES OF INCORPORATION

OF

LABAMBA OF 98, INC.

The undersigned natural person, at least eighteen (18) years of age, for the purpose of forming a corporation for profit, pursuant to the provisions of Chapter 607, Florida Statutes, does hereby certify the following:

ARTICLE I - NAME

The name of this corporation is LaBamba of 98, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence unless sooner dissolved by law.

ARTICLE III - PURPOSE
