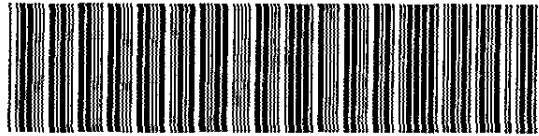

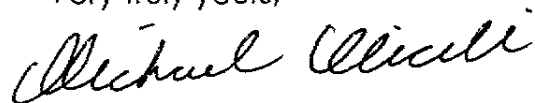

The undersigned Incorporator, for the purpose of forming a corporation under Chapter 607 of the laws of the State of Florida, hereby makes, acknowledges, and files the following Articles of Incorporation:

ARTICLE I. NAME

The name of this corporation shall be FAST HOLDING COMPANY, INC. ("Corporation").

ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the Corporation shall be 9517 Gulf Shore Drive, Unit 201, Naples, Florida 34108.

ARTICLE III. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or businesses permitted under the laws of the United States of America, the State of Florida or any other state, county, territory, or nation.

ARTICLE IV. DURATION

The Corporation shall commence its existence on the date these articles of incorporation are filed by the Florida Department of State. The Corporation's existence shall be perpetual, unless the Corporation is earlier dissolved as provided in these articles of incorporation.
