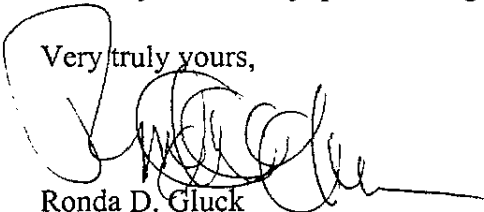

NAME**

The name of this Corporation is HUZE, Inc.

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, or any amendment hereto, as provided by law.

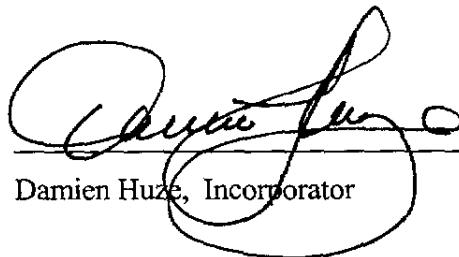
ARTICLE 10
