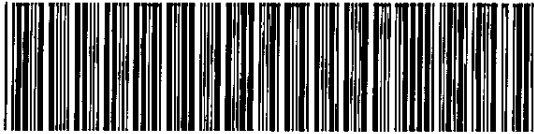

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is MACK Professional Packaging International, Inc., and the principal address and principal place of business is 7500 Ulmerton Road, Suite 26, Largo, Florida 33771.

ARTICLE II - REGISTERED OFFICE AND AGENT

The address of its registered office in the State of Florida is c/o STEVEN W. MOORE, P.A., 8200 Bryan Dairy Road, Suite 300, in the City of Largo, County of Pinellas, Florida 33777. The name of its registered agent at such address is Steven W. Moore.

ARTICLE III - PURPOSE
