The undersigned Incorporator, for the purpose of forming a corporation under Chapter 607 of the laws of the State of Florida, hereby makes, acknowledges, and files the following Articles of Incorporation:

ARTICLE 1. NAME

The name of this corporation shall be JEANINE JACKSON PEOPLEScape, INC. ("Corporation").

ARTICLE II. ADDRESS

The mailing address and street address of the principal office of the Corporation shall be 5945 Tarpon Gardens Circle, Cape Coral, Florida 33914.

ARTICLE III. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or businesses permitted under the laws of the United States of America, the State of Florida or any other state, county, territory, or nation.

ARTICLE IV. DURATION
