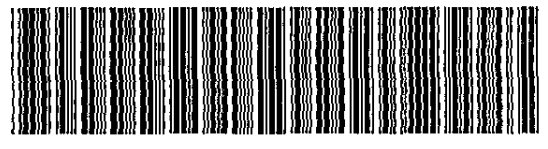

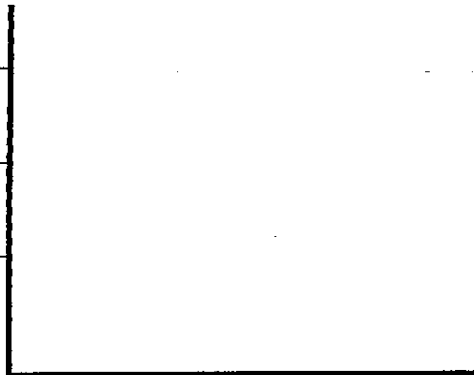

The undersigned hereby acts to form a corporation under the laws of the State of Florida, by and under the provisions of the statutes of the State of Florida, providing for the formation, liability, rights, privileges and immunities of a corporation for profit.

**ARTICLE I
NAME**

The name of this corporation shall be Academic Interventions, Inc.

**ARTICLE II
GENERAL NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is to engage in any activity or business permitted under the laws of the United States and of the State of Florida. Without limiting the foregoing, the corporation shall also provide evaluation, tutorial and other academic enrichment activities, including supplemental education services, to preschool and school-age children with and without disabilities.

**ARTICLE III
STOCK**

The authorized Capital Stock of this corporation shall consist of one hundred (100) shares of one dollar (\$1.00) par value common stock, which shall initially be owned by Supreme Evaluations, Inc.

**ARTICLE IV
CORPORATE EXISTENCE**

This corporation shall exist perpetually unless dissolved according to law.

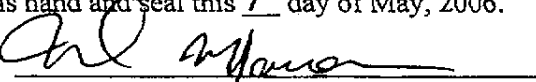
**ARTICLE IX

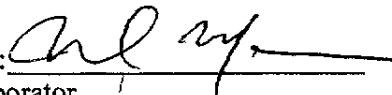
