**ARTICLE 1  
NAME AND ADDRESS**

**ARTICLE 2  
DURATION**

The corporation shall commence upon the filing of these Articles of Incorporation and shall have perpetual existence thereafter.

**ARTICLE 3  
PURPOSE**
