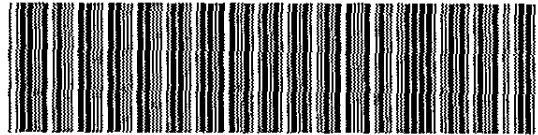

ARTICLE VIII

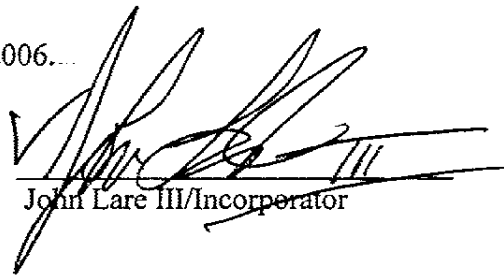
