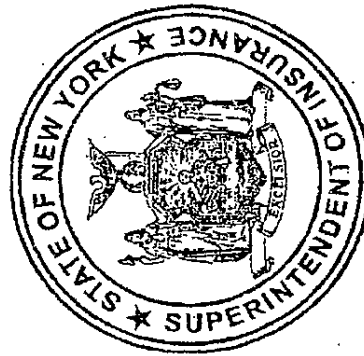

**CERTIFICATE OF AMENDMENT TO
THE CHARTER OF**

AIG NATIONAL INSURANCE COMPANY, INC.

Under Section 805 of the Business Corporation Law and Section 1206 of the Insurance Law

We, the undersigned, Anthony J. DeSantis and Esta L. Cain, President and Secretary respectively of American National Insurance Company, Inc. hereby certify as follows:

FIRST: The name of the corporation is AIG National Insurance Company, Inc.

SECOND: The certificate of incorporation of the corporation was filed with the Insurance Department on December 12, 1994.

THIRD: The purpose of the Certificate of Amendment is to effectuate the corporation's name change from AIG National Insurance Company, Inc. to 21st Century National Insurance Company and change of domiciliary address from the County of New York, State of New York to the County of Nassau, State of New York.

FOURTH: The amendments effected by this certificate of amendment are as follows:

"Section 1. The name of this company shall be 21st Century National Insurance Company."; and

"Section 2. The principal office of this corporation shall be located in the County of Nassau, State of New York. The Corporation shall have the power to establish other offices in this state and elsewhere in the United States and in any part of the world and to conduct its business wherever authorized by law."


FIFTH: The Certificate of Amendment was adopted by Unanimous Written Consent of the Board of Directors of the corporation dated December 4, 2009.

SIXTH: The Certificate of Amendment was adopted by Unanimous Written Consent of the Shareholders dated December 4, 2009.

SEVENTH: The effective date of the Certificate of Amendment to the Charter shall be April 1, 2010.
