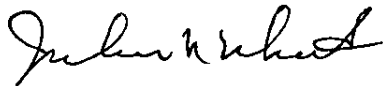

4. The names, titles and addresses of its officers and directors are as follows:

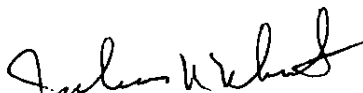

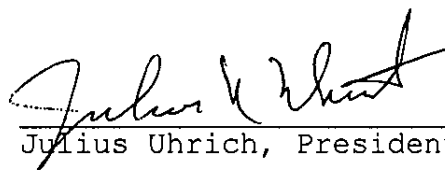
The special meeting of the Board of Directors of the above-captioned Corporation was held on August 1, 2010 at 2150 Diamond Ct., Oldsmar, Florida.
