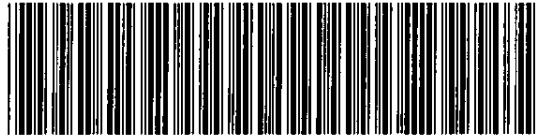

No stockholder of the corporation may sell or transfer stock in the corporation except to another individual, professional corporation, or professional limited liability company who is eligible to be a stockholder of the corporation, unless the sale or transfer has been approved at a stockholder meeting especially called for that purpose.

**Article X Indemnification**

The corporation shall indemnify its directors, officers, employees, and agents to the full extent permitted by law.


**Article XI Amendment**

**Article XII Effective Date**


