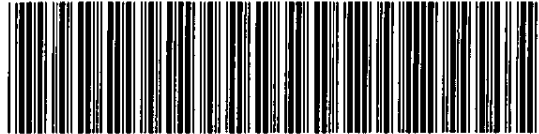

ARTICLE I NAME

The name of this corporation is B CAUSE MARKETING GROUP, INC.

ARTICLE II ADDRESS

The corporation's address is 2635 West Prospect Road, Tampa, Florida 33629.

ARTICLE III COMMENCEMENT OF CORPORATE EXISTENCE

The corporation's existence will commence January 20, 2009; provided however, that such date is within five business days prior to the date these Articles of Incorporation are filed by the Department of State of the State of Florida. If such date is not within five business days of the date of filing, then the corporation's existence will commence on the date these Articles of Incorporation are filed by the Department of State of the State of Florida.

ARTICLE IV BUSINESS AND POWERS

The following individual will be the initial director of the corporation:


